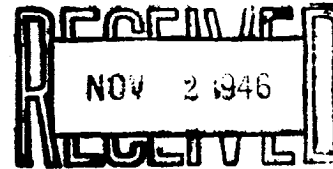

## FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

On October 31, 1946, the 9-5/8" ODS and the 36" Range 8-40-R new A.O. Smith SS casing was set at 2906' in the Anhydrite. Cemented with 1000 sack Portland and 300 sack Trinity High Early Set sack cement, by Halliburton method. The plug was pumped to 2865'. Job completed 7.35 PM.

Propose to drill plug and test shut off 7.35 PM November 2, 1946.
