## FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

At 11:00 a.m. on November 23, 1946, 48 hours will have elapsed since running 13-3/8" 54.5# Grade J-55 casing at 287 in subject well, and cementing with 250 sacks cement to be used as surface string. At time mentioned, casing shut off will be tested as follows:

A pressure of 750# will be built up and held for 30 minutes, and if test is Ok, cement plug will be drilled and a pressure of 750# again built up to hold for 30 minutes. If this test is also Ok, drilling operations will be resumed.
