7805' Drilled out depth, Gun Perforated with McCullough from 7771 to 7803' with 4 shots per foot, total of 128 shots, Ran 2" EUE Tubing to 7797' and displaced mud with water and water with 190 barrels oil, put on Xmas tree and started swabbing at 1AM and well started flowing at 2:15AM 11-1-46 and in 5 hours on 1" Choke made 219.22 barrels of oil 3/10% BS&W Casing Pressure zero, Tubing Pressure 200, Gas Volume 868M and Gas-Oil-Ratio 826. Well Completed
