Re: Application to Dually Complete
Amerada H. Corrigan #11, Brunson
Pool, Lea County, New Mexico.

Gentlemen:

By this letter of application Amerada Petroleum Corporation wishes to state the following:

(a) That Amerada Petroleum Corporation H. Corrigan #11 located in the NW 1/4 of the NE 1/4 of Section 4, Township 22-S, Range 37-E was completed November 25, 1947 at a total depth of 7600'. The attached Exhibit A shows the location of this well on the Amerada H. Corrigan Lease together with the locations of all offset wells.

(b) That subject well has 5 1/2" casing set at 7600' and cemented with 650 sacks cement. The well is an oil well producing from the perforated intervals of 7410' to 7445', 7460' to 7510' and 7530' to 7570' in the Brunson Zone, Brunson Pool.

(c) That the applicant proposes to dually complete the well in the following manner:

(1) Perforate 5 1/2" casing within the approximate interval of 5550' to 5775' in the Plinebry Formation, Plinebry Gas "ool.

(2) Set production type packer below these perforations at approximately 5785' to separate the two zones.

(3) Produce the Brunson oil through the tubing and the Plinebry gas through the tubing-casing annulus.

(d) That the granting of this application for permission to produce the well as a dual completion with gas from the Plinebry and oil from the Brunson is in the interest of conservation and the protection of correlative rights.

(e) That the applicant will comply with all rules and regulations of the New Mexico Oil Conservation Commission to maintain separation of production from the two pay zones.

(f) That the manner and method of the proposed dual completion is mechanically feasible and practical.

(g) That by copy of this letter of application all offset operators are notified of the proposed dual completion.

Therefore, Amerada Petroleum Corporation requests that the Oil Conservation Commission grant permission to the applicant to finally complete the subject well as proposed in this application.
