DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Completed 8-1-52, after installing Reda pump. Reda equipment from bottom up as follows: 97.5 HP Reda motor, Reda Type 44 series 540 protector. Reda Type 42 series 540 auxiliary grease reservoir, then Reda type B-16 223 stage series 450-540 pump. Reda standing valve 1 jt above pump, Reda KO plug 2 jts above pump, bottom of motor at 7961'. Pump intake at 7932'.

RESULTS: Initial pumped 93 oil 412 water thru 2-3/8" tubing in 24 hrs ending 8-1-52. 24 hour gas volume 180,900 cuft. GOR 1945/1. 78 amps. TP 20#. CP 20#. Allowable 101 bpd, exempt. Daily average production before workover - dead. Allowable before workover none.
