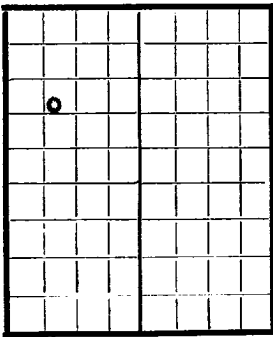
NOTICE OF INTENTION TO DRILL
