FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

We propose to carry 7-7/8" hole to 8,097', run 5-1/2" OD 17# casing to total depth, cement with 100 sacks, run temperature survey, perforate and stage cement as necessary. 2,000# pump pressure will be pumped on casing before and after drilling cement out to approximately 8,092ft. and will be allowed to stand for 30 minutes to check pressure decline.

We expect to do this work on July 28th, 1946.
