DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

8-5/8" O D 32# 10 Thread S H Casing was set in the anhydrite at 1165', cemented with 50 sacks. Hole was bailed dry; tested for 2 hours, showed no water; drilling resumed.

160' of 40# 10 thread S H 10" was run, mudded and cemented with 100 sacks cement back to bottom of cellar, after which shut off casing was pulled.
