FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production it is proposed to plug back and fracture treat as follows:

1. Pull tubing.
2. Run steel line measurement. Clean out with sand pump if necessary.
3. Plug back with Hydromite to 3710'.
4. Run 2-7/8" tubing with Lynes self-anchoring packer at 3630'.
5. Treat with 8,000 gallons gelled lease oil with 1# sand per gallon.
6. Pull 2-7/8" tubing and packer, rerun 2-3/8" tubing with seating nipple.
7. Swab and test.
