for Approval of an 80-acre Non-Standard
Gas Proration Unit, Blinebry Gas Pool,
Lea County, New Mexico

Gulf Oil Corporation respectfully requests exception to Rule 5(A) of Order R-1670 for administrative approval of an 80-acre Non-Standard Blinebry Gas Proration Unit covering the S/2 NW/4 Section 5, Township 22 South, Range 37 East, Lea County, New Mexico. This Non-Standard Unit is to be attributed to the Lee Stebbins (NCT-A) Well No. 3, located 1870 feet from the north line and 2092 feet from the west line of Section 5.

In support of this application, the following facts are submitted:

- (1) Applicant's Lee Stebbins (NCT-A) Well No. 3 was originally completed as a Drinkard oil well in April, 1951. This well has now been recompleted as a Blinebry gas well.
- (2) The proposed Non-Standard Gas Proration Unit consists of contiguous quarter-quarter sections and lies wholly within a single governmental quarter section.
- (3) The entire Non-Standard Gas Proration Unit is reasonably presumed to be gas productive in the Blinebry Gas Pool.
- (4) The length or width does not exceed 2640 feet.

All operators owning interests in the quarter section in which the Non-Standard Gas Proration Unit is located and all operators within 1500 feet of the unit well have been furnished a copy of this application.
