Re: Application to Dually Complete Gulf  
Oil Corporation's Lee Stebbins "A"  
No. 3, Tubb Gas and Drinkard Oil  
Pools, Lea County, New Mexico

Gentlemen:

By this letter of application, Gulf Oil Corporation wishes to state the following:

(a) That Gulf Oil Corporation's Lee Stebbins "A" No. 3, located 1870' FNL and 2092' FNL of Section 5-22S-37E, was completed on August 2, 1951 at a total depth of 6595'. The attached Exhibit "A" shows the location of this well on the Gulf Oil Corporation's Lee Stebbins "A" Lease together with the location of all offset wells. The attached Exhibit "B" shows a diagrammatic sketch of the proposed dual completion.

(b) That subject well has 7" casing set at 6532' and cemented with 730 sacks of cement. The well is an oil well producing from the open hole interval from 6532-6595' from the Drinkard formation in the Drinkard Pool.

(c) That the applicant proposes to dually complete the well in the following manner:

- (1) Perforate the 7" casing within the approximate intervals of 6090-6295' in the Tubb formation in the Tubb Gas Pool.
- (2) Set production type packer below these perforations at approximately 6385' to separate the two pay zones.
- (3) Produce the Drinkard Pool oil through the tubing and the Tubb gas through the tubing-casing annulus.

(d) That the granting of this application for permission to produce the well as a dual completion with gas from the Tubb and oil from the Drinkard is in the interest of conservation and the protection of correlative rights.

(e) That the applicant will comply with all rules and regulations of the New Mexico Oil Conservation Commission to maintain separation of production from the two pay zones.



(f) That the manner and method of the proposed dual completion is mechanically feasible and practical.

(g) That by copy of this letter of application, all offset operators are notified of the proposed dual completion.

Therefore, Gulf Oil Corporation requests that the Oil Conservation Commission grant permission to the applicant to dually complete the subject well as proposed in this application.

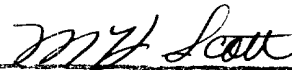
