This well is presently pumping approximately 1 BOPD from the Drinkard. It is proposed to plug back and test the Blinebry horizon. It is our intent to set a retrieveable bridge plug above the Drinkard perforations (6440-6478'), perforate and stimulate the Blinebry horizon and test. The proposed perforations are 5840-5655'. After a conclusive test and determination of bottom hole producing conditions, consideration will be given to requesting authority to commingle downhole, or permanently plug the well as per NMOCC requirements. Current data from surrounding wells indicate that successful downhole commingling of both zones can be accomplished for additional oil recovery.
