After drilling 11 3/4" hole to 2901' - 8 5/8" 32# casing was run to 2900' and cemented with 1500 sks. of cement. Cement circulated to surface.

After 61 hrs set time on cement plug was drilled with 7 7/8" bitt. casing and cement both were tested with 1300# pump pressure and found to be O.K.
