Intended Procedure: It is proposed to acid treat the well according to the following procedure:

1) Rig up, pick tubing up out of packer, 2) Spot acid and acidize with 1000 gallons of gel and 3000 gallons of low tension acid, 3) Swab out acid load and test, 4) Tear down and place well on production.
