Present production: 11.84 barrels per day. Formation lime.

Intended Procedure: It is proposed to acid treat the well according to the following procedure: 1) Rig up and pull rods and 2-inch tubing, 2) Re-run 2-inch tubing and Baker retrievable packer, 3) Circulate with oil and treat with 1750 gallons of gel blocking agent and 10,000 gallons of low tension acid, 4) Swab out acid load and test, 5) Kill well, pull 2-inch tubing and packer; re-run 2-inch tubing and rods, 6) Tear down and place well on production.
