Gentlemen:

By this letter of application Amerada Petroleum Corporation wishes to state the following:

(1) That the Amerada Petroleum Corporation A.B. Baker No. 3 located 589 feet from the East line and 2051 feet from the South line of Section 10, Township 22 South, Range 37 East, Lea County, New Mexico is a gas-gas dual in the Elinebry and Tubb Gas Pools.

(2) That the applicant proposes to assign to this well in both the Elinebry and Tubb Gas Pools an 80 acre non-standard gas proration unit consisting of the E/2 of the SE/4 of Section 10, Township 22 South, Range 37 East.

(3) That gas proration orders in the past have shown 80 acres dedicated to this well in each pool. However, a non-standard proration unit order has never been issued by the Commission for this well.

(4) That the proposed non-standard gas proration units lie wholly within a governmental section.

(5) That the proposed non-standard gas proration units consist of two contiguous governmental quarter-quarter sections.

(6) That all the acreage in the proposed non-standard gas proration units may reasonably be presumed to be productive of gas in both pools.

(7) That by a copy of this letter of application all offset operators are being notified of these proposed non-standard gas proration units.

Therefore, in view of the facts stated above, Amerada Petroleum Corporation respectfully requests that the Secretary of the Commission, through provisions of Orders R-586 and R-610 approve non-standard gas proration units in the Elinebry and Tubb Gas Pools for the A.B. Baker No. 3.
