By this letter of application Amerada Petroleum Corporation wishes to state the following:

(a) That Amerada Petroleum Corpo ation A. B. Baker #3 located in the NE/4 of the SE/4 of Section 10, T-22-S, R-37-E, being 593' FNL and 639' FEL of the lease, was completed January 22, 1947 at a total depth of 6496'. The attached Exhibit A shows the location of this well on the Amerada Baker lease together with the location of all effset sells.

(b) That subject well has 5-1/2" casing set at 6496' and cemented with 350 sacks cement. The well is a limited production oil well producing from the perforated interval of 6442 to 6476 in the Drinkard Zone, Drinkard Pool.

(c) That the applicant proposes to dually complete the well in the following manner:

(1.) Set a bridge plug at approximately 6150' and dump

- (2.) Perforate 5-1/2" casing within the approximate interval of 5950' to 6135' opposite the Tubb zone, Tubb Gas zone; and within the approximate interval of 5370' to 5615' opposite the Blinebry Zone, Blinebry Gas Pool.
- (3.) Set production type packer below the Blinebry perforations at approximately 5625' to separate the two pay zones.
- (4.) Produce Tubb gas through the tubing and Blinebry gas through the tubing casing annulus.

(d) That the granting of this application for permission to produce the well as a dual completion with gas from the Tubb zone and gas from the Blinebry Zone is in the interest of conservation and the protection of correlative rights.

(e) That the applicant will comply with all rules and regulations of the New Maxico Oil Conservation Commission to maintain separation of the two pay gones.

(f) That the manner and method of the proposed dual completion is mechanically feasible and practical.
