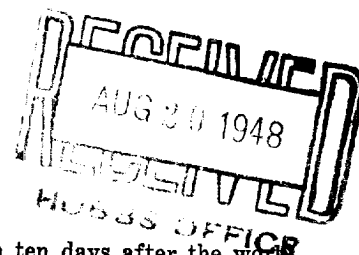

2675' Total Depth, Line. ~~Run~~ Ran temperature survey and found top of cement at 474', 33.2% of calculated fill. Nipped up 8-5/8" OD Casing, went in hole with 7-7/8" bit and drilled out cement from 2584' to 2675'. Tested casing with 1000# for 30 minutes before and after drilling cement and OK. Started drilling 7-7/8" from 2675' at 3:15AM, 8-19-48.
