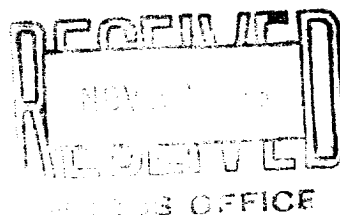

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The hole was washed down and the casing tested with 1200# pressure applied for 30 minutes. The plug was drilled and the hole tested with 1200# pressure applied for 30 minutes. Both tests were OK, and after approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to complete the well.

Temperature survey showed top of cement behind 7" casing at 2575' from surface.
