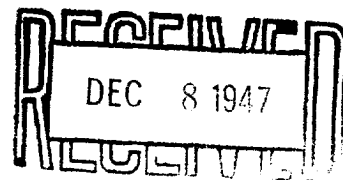

On December 3, 1947 ran 196 joints new 7" OD 23#, 8 Rd Thd H Y & J-55 SS Casing. (17 joints AO Smith HY Range 3, Short thd & collar on bottom and 179 joints J-55 Nat'l. Range 2 Long Thd & collar on top) w/1 - 7" Weatherford csg centralizer placed at 6426'. Tallies 6419', H-11', set at 6430'. Cemented by Halliburton w/575 sacks 2% & 125 sacks neat bulk cement. Plug at 6389'. Job started 12:30 AM and ~~xxx~~ completed 10:30 AM.

Propose to drill plug and test shut-off at 10:30 AM December 5, 1947.


TO THE EDITOR:
I am writing to inform you of the results of our recent experiments on the reaction of C_6H_6 with $\text{C}_6\text{H}_5\text{MgBr}$ in the presence of $\text{C}_6\text{H}_5\text{Li}$. The reaction was carried out in C_6H_6 at -78°C for 24 hours. The product was isolated and purified by distillation. The yield was 85%. The product was identified as $\text{C}_{12}\text{H}_{10}$ by mass spectrometry and infrared spectroscopy. The melting point was 105°C . The product was found to be a new compound, and its structure is shown below.

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The hole was washed down and the casing tested with 1200# pressure applied for 30 minutes. Plug was drilled and the casing tested with 1200# pressure applied for 30 minutes. Both tests were OK, and after approval of Mr. Yambrough, State Oil and Gas Inspector, preparations were made to drill ahead.

Top of cement behind 7" casing at 1730' per temperature survey.
