Gentlemen:

By this letter of application Gulf Oil Corporation wishes to state the following:

(a) That the Gulf Oil Corporation Raves No. 6, located in the NE/4 NE/4 of Section 10, T-22-S, R-37-D, was completed March 17, 1949 at a depth 6495'. The attached Exhibit "A" shows the location of this well on the Gulf Oil Corporation Daves Lease together with the location of all offset wells.

(b) That subject well has 7" casing set at 6440' and comented with 700 sacks of cement. The well is a gas well producing from the open-hole interval 6440-6495' in the Drinkard Pool.

(c) That the applicant proposes to dually complete the well in the following manner:

(1) Perforate the 7" casing within the approximately interval of 5390-5520' in the Blinebry Cas Pay.

(2) Set production type packer below these perforations at approximately 5600' to separate the two pay zones.

(3) Produce the Drinkard oil through the tubing and Blinebry gas through the tubing-casing annulus.

(d) That the granting of this application for permission to produce the well as a dual completion with oil from the Drinkard and gas from the Blinebry is in the interest of conservation and the protection of correlative rights.

(e) That the applicant will comply with all rules and regulations of the New Mexico Oil Conservation Commission to maintain separation of production from the two pay zones.

(f) That the manner and method of the proposed dual completion is mechanically feasible and practical.
