4. Run 3-1/2" tubing and "RTTS" Packer.
5. Fracture open hole section 3600-3735' with 20,000 gallons sand - oil.
6. Shut and test well.
7. Pull 3-1/2" tubing and packer.
8. Run 2" tubing and rods.
9. Put well to pumping.
