- 1) Move in pulling unit. Pull pump and rods.
- 2) Perforate 5-1/2" OD casing with one shot per foot as follows: 6372-6376', 6380-6382', 6384-6394', 6402-6406', 6411-6415', 6417-6420', and 6423-6425'.
- 3) Pump into formation and inject enough blocking material (Benzoic acid flakes and rock salt) to block off present perforations 6438-6536'.
- 4) Treat new perforations 6372-6425' with 3000 gallons of 15% NE acid.
- 5) Run rods and pump.
- 6) Return well to production.
