- 1) Move in pulling unit. Pull rods and tubing.
- 2) Run Gamma Ray-Neutron Log.
- 3) Set bridge plug at approximately 6490'.
- 4) Perforate upper Drinkard as indicated by Gamma Ray-Neutron Log.
- 5) Treat added perforations with 3000 gallons of acid.
- 6) Pull bridge plug at 6490'.
- 7) Run tubing and swab test added perforations and existing perforations 6500-6520'.
- 8) Install necessary producing equipment and return well to production.
