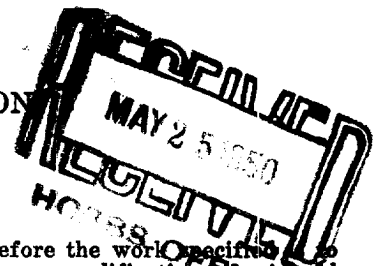

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

This well was completed November 16, 1948, at a T.D. of 5230' w/ 7" casing on bottom and casing perforated opposite the 3rd Glorieta zone from 5205-5230'. The production having declined at the present time to approximately 35 bbls. per day, it is proposed to perforate additional pay opposite the 2nd zone, and acidize w/ approximately 1000 gals. 15% regular acid in an attempt to regain top allowable production from this well.
