- Treat Tubb formation (5887-6119) thru 2-1/16" tubing as follows
 - Pump 3000 gals Isopropyl Alcohol at 1 BPM w/ 1500 SCFN2/BHL for a 5 to 1 Atomized ratio
 - Displace treatment into formation w/52,000 SCFN2
 - SI 1 hr then flow back (unless pressure drops off rapidly, in which case well should be flowed back earlier)
CO NOT EXCEED 5000 PSI SURFACE TREATING PRESSURE
- Return to production
Fluid should be: 3000 gals Isopropyl Alcohol
200,000 SCF Nitrogen
