1. Dug well cellar out to expose all casing bradenhead outlets.
2. Installed 1" piping from 2" valve on outlet on each bradenhead to a point above ground level. Installed 1" valve on upper end of piping.
3. Ran bradenhead pressure. Survey indicated no leak.
4. Piping arrangement, open position of 2" valve and closed position of 1" valve, inspected and approved by New Mexico Oil Conservation Commission Deputy Oil and Gas Inspector, Leslie Clements.
