### FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

We are running, today, a string of 5½" casing to a depth of 7022'. The bottom 750' of this string is 17 pound pipe and the remainder is 15½ pound. Total depth of hole is 7387' and is bottomed in granite.

We have run a Schlumberger survey on this hole and found that the deepest pay indicated lies between the depths of 6800' and 6900'. We propose to gun perforate this zone after allowing cement 72 hours in which to set. We also propose to test a zone, or zones, between the approximate depths of 6350' and 6500' and another zone between the depths of 5450' and 5600'. We will test the Melt zone between the depths of 5100' and 5200'.
