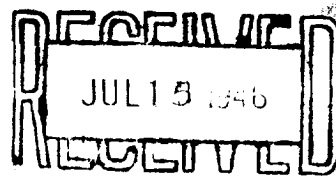

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Cement was allowed 48 hours in which to set on 8-5/8" 32# casing cemented at depth of 1200' with 600 sacks on June 30, 1946, before being tested.

Plug was drilled and casing pressure tested with 1200#. Test proved to be O.K. and drilling was resumed.
