The Ohio Oil Company respectfully requests that the Oil Conservation Commission grant this application of The Ohio for authority to dually complete its Edith Butler "B" Well No. 1, located in the NE/4 SE/4 of Section 13, Twp. 22-S, Range 37-E, Lea County, New Mexico, new producing oil from the Drinkard Oil Pool. The Ohio desires to dually complete this well in the Tubb Gas Pool in such a matter as to produce gas through the annulus between the casing and tubing and to continue producing oil from the Drinkard Oil Pool through the tubing. The Onio intends to install an efficient packer between the two zones and to perform the completion so as to prevent waste in each reservoir. A schematic diagram showing the proposed method for dually completing this well is attached. Subsequent to the completion of the work, Ohio will present to the Commission data showing the detail completion program as well as plans for future testing which will be made regularly to determine that waste is not occurring in either reservoir.

The New Mexico Oil Conservation Commission Order No. DC-247, dated October 27, 1955, granted the Ohio authority to dually complete the Edith Butler "B" Weil No. 1 in the Blinebry Gas Pool and Drinkard Oil Pool. The dual completion in the Blinebry Gas Pool and the Drinkard Oil Pool was not attempted, and The Ohio Oil Company now desires to dually complete the well in the Tubb Gas Pool and Drinkard Oil Pool.

The Ohio Oil Company further respectfully requests approval under the provisions of Rule 5 (d) of the Special Rules and Regulations for the Tubb Gas Poul, Order No. R-586, for an 30 acre non-standard proration unit,
