Perforate $5\frac{1}{2}$ " casing in Blinebry section at approximately 5440' to 5463' and 5475' to 5550', and sand frac thru perforations w/12,000 gallons sand oil and complete for gas and distillate production. Producing Drinkard oil thru tubing and Blinebry thru $5\frac{1}{2}$ " casing annulus.
