We propose to set Halliburton DC Bridge plug at 6050; squeeze w/400 sx. regular cement through existing perforations 6070-6753'; then perforate w/l shot/ft from 5670-5671; squeeze w/120 sx. regular cement; perforate w/l shot/foot 5410-17; squeeze with 120 sx; perforate 5570-5620; treat with 500 gal. mud acid and 3,000 gal. regular acid; set Baker retrievable bridge plug 5510 and perforate 5435-5500; treat with 500 gal. mud acid and 3,000 gal. L.T. acid.
