On January 7, 1946, the 9-5/8" OD 8 Rnd. Thd. 36# Grade H-40 Range 2 SS Casing was set in Anhydrite at 2849' and cemented by Halliburton Oil Well Cementing Company with 1200 sacks 2% ~~of~~ ^{dry} Portland and 100 sacks neat cement. The plug was pumped to 2806'. The job was started at 8.00 AM and completed at 1.45 PM.

We propose to drill plug and test shut off at 1.45 PM January 9, 1946.
