FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production it is proposed to plug back and fracture treat as follows:

1. Pull tubing and packer.
2. Run steel line measurement. Clean out with sand pump if necessary.
3. Plug back to 3705' with Hydromite. Squeeze each dump with oil if necessary.
4. Run 2-7/8" tubing with Lynes self anchoring packer. Set packer at approximately 3620'.
5. Treat formation with 8000 gallons gelled lease oil with 1# sand per gallon.
6. Pull 2-7/8" tubing and packer. Run 2-3/8" tubing with Hookwall packer.
7. Swab and test.
