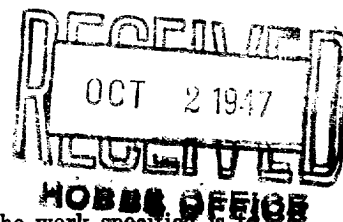

Cemented by Halliburton with 300 sacks neat sack cement. Plug at 39'. Cement circulated OK. Job started 11:45 AM and completed 3 PM.

Propose to drill plug and test shut-off at 3 AM September 28, 1947.
