Gentlemen:

This letter is to request that the Oil Conservation Commission schedule a hearing to consider our Application for Approval of 160 acre Non-Standard Gas Proration Unit, being the W/2 of the SW/4 and the W/2 of the NW/4 of Section 17, Township 22 South, Range 37 East, Lea County, New Mexico, to be assigned to New Mexico State "M" Well No. 12, located 660' from the South line and 660' from the West line of Section 17, Township 22 South, Range 37 East, Lea County, New Mexico. In support of this request we submit the following information:

1. New Mexico State "M" Well No. 12 now producing as an oil well from the Queen Zone, Belmont Pool, with an assigned 40 acre unit described as being the SW/4 of the SW/4 of Section 17, T-22-S, R-37-E, Lea County, New Mexico. We plan to work this well over by perforating the gas zone in the Queen Sand and Sand Frac the new perforations with 24,000 gallons of refined oil and 36,000 pounds of sand, in three 8,000 gallon stages.
2. The proposed Non-Standard Proration Unit consists of contiguous quarter, quarter sections.
3. The entire proposed Proration Unit may reasonably be presumed to be productive of gas.
4. The length or width of the Non-Standard Proration Unit does not exceed 5280'.
5. The 160 acre Unit to become effective after approval has been received from the Conservation Commission and the workover completed.
6. A plat is attached of the proposed 160 acre Non-Standard Proration Unit, also a gas well plat and a lease plat showing all offset operators and pertinent lease information.
