2. Ran 30 Jts. 2" tubing & Guiberson (5-1/2" X 2") shorty tension packer. Set @3532' and test to 1300# for 30 min. O.K. Set packer @3231'. Swab back 97 Bbl. fluid. TPT-43 (Used 140 BF to kill well)
3. TP-700# FTP-200# on 3/4" choke. Killed well & Ran 6 Jts. 2" tbg. & set pkr. @3411' between perfs. 3448-3520'; 3278-3346'. Swab to flow. Recovered fluid.
4. Kill well. Ran 4 Jts. 2" tbg. (120') & set pkr. @3531'. Swab & test above pkr. & plug. Plug leaking. Pull tbg. & pkr.
5. Rigged up. Set CIBP @3560' w/2 sks. cement. Ran 113 Jts. 2-3/8" J-55 tbg. (3496') SN & pkr. (5-1/2" X 2" - 2'10" long) Set pkr. & 3204'. 15,000# on pkr. O.K.
6. Flow test to pits. Water shut off.
7. Average test first 6 hours. 1150 MCF
