Re: Application to Dually Complete  
Rowan Oil Company #7 Will Cary

Gentlemen:

In support of the subject application, the Rowan Oil Company submits the following:

- (1) Rowan Oil Company #7 Will Cary, SE/4 of NW/4, Section 22, Twp 22S, R 37E, Lea County, New Mexico, was completed January 21, 1949, through perforations opposite the Drinkard formation from 6280 to 6305'.


You have in your file Exhibit A showing the location of this well and the proposed 160 acre proration unit; also you have Exhibit B, a copy of the electrical log showing plug back depth, formation tops, total depth, elevations, and proposed perforations. Attached is Exhibit 'C', a plat showing the proposed dual completion.

- (2) The subject well has 5-1/2" casing, cemented at 5414' with 350 sacks of cement, and the total depth is 6467'. The well is now producing approximately 7 barrels of oil per day from the Drinkard.
- (3) The applicant proposes to complete the subject well in the following manner:
  - (a) Perforate the 5-1/2" casing within the approximate interval of 5495 to 5550'.
  - (b) Set production type packer at 5700' to separate the Blinebry perforations, 5495 to 5550', from the Drinkard perforations, 6280 to 6305'.
  - (c) Produce the Drinkard oil through the tubing and the Blinebry gas through the tubing-casing annulus.
- (4) The approval of this application to dually complete the subject well is in the interest of conservation and the protection of correlative rights and the operator will comply with all rules and regulations to maintain separation of production of the two pay zones.
- (5) A copy of this letter of application has been mailed to each offset operator.

The Rowan Oil Company respectfully requests the Conservation Commission to grant permission to the applicant to complete the subject well as proposed in this application.


