Dear Mr. Stamets:

Pursuant to Rule 104 of the Statewide Rules of the New Mexico Oil Conservation Commission, Gulf Oil Corporation (Gulf) and Summit Energy, Inc., (Summit) hereby request that the subject Blinebry communitization unit established by a July 6, 1956, pooling agreement be now terminated. Gulf is the operator and holds a 75% gross working interest on the premises. Summit holds the remaining 25% gross working interest.

It is Gulf's intention to rework the Amanda #1 Well which is the present unit gas well. This reconditioning will result in an oil rather than a gas well. If this effort is successful, both Gulf and Summit may individually complete additional oil wells on the subject premises in accordance with the spacing rules of the Commission. The Amanda #1 Well is in an orthodox location.
