

We need you to move-in on this well immediately and do a workover since this well is a multiple completed in the Blinebry Pool and the Brunson Drinkard Abo South Pool. Your procedure needs to be reported on the form C-103 and mailed to Oil Conservation Division, P O Box 1980, Hobbs NM.

Your allowable will be cancelled effective January 1, 1993 by the Oil Proration Schedule for both zones.
