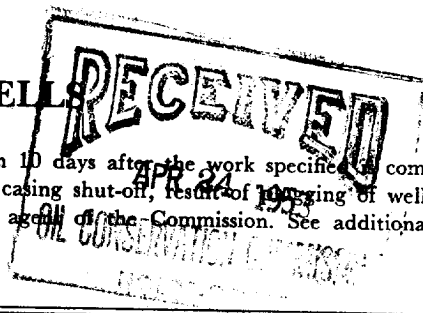

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

A 17" hole was drilled to depth of 166' and 9-5/8" 29.3 Spiral Weld casing was cemented on bottom with 130 sacks. Cement circulated back into collar. 152' of casing was left in hole.

Cement was allowed a set time of 24 hours before being tested for water shut off. Test showed cement job to be O K.
