The following remedial work is estimated to commence by November 1, 1975 to repair a small leak of gas and water at the surface of the well. This C-103 is submitted per Mr. Leslie Clements letter of August 25, 1975.

1. Cut holes in 2 7/8" casing at 2500', more or less.
2. Establish circulation to the surface.
3. Cement with 400 sacks.
4. Wait on cement.
5. Observe well at surface to see if leak has ceased.
6. If leak has not ceased, reperforate and cement again.
