(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Workover procedure:

1. Set non-retrievable cement retainer at 3700 feet.
2. Squeeze off perforated intervals 3709-3728; 3736-3756 feet with retarded, low fluid loss cement. (use 50 sx.)
3. Perforate 2-7/8-inch casing 3672-3676 feet with 2 jets per foot.
4. Acid wash perforated intervals 3655-3667 feet; 3672-3676 feet; and 3682-3688 feet and break down.
5. Sand-oil frac perforated intervals with 10,000 gallons Humble Frac, 11 pounds sand per gallon.
