- Moved in and rigged up workover rig 10-13-70. Pulled rods and tubing.
- Ran 2-3/8" OD tubing internally lined with Cemline cement coating and set Halliburton R-4 packer at 3514'.
- Loaded casing annulus behind tubing with water treated with inhibitors.
- Hooked well to injection system and began injecting water on October 14, 1970, into the Penrose Sand through 5-1/2" OD casing perforations 3600-3770'.

This is a water injection well for the Skelly Penrose "B" Unit operated by Skelly Oil Company.
