FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production it is proposed to fracture treat as follows:

1. Pull tubing, rods and pump. Run steel line measurement and clean out with sand pump.
2. Run 2-7/8" tubing with hookwall packer and hydraulic holddown. Treat formation with 12,000 gallons gelled lease oil with 1# sand per gallon, followed by 400 gallons crushed moth balls in gelled crude, followed by 8000 gallons gelled lease oil with 1# sand per gallon.
3. Pull 2-7/8" tubing, packer and holddown. Run 2-3/8" tubing and return well to production.
