- 1) Move in workover rig. Pull tubing and packer.
- 2) Perforate 5" OD liner at +3550', 3570', 3610', 3637', 3643' with 1 shot each place.
- 3) Treat Lancie-Mattix perforations 3550' 3643' with 3000 gallons 15% ^{water} HCl acid and ball sealers.
- 4) Set lined injection tubing and packer at +3500' with treated in annulus.
- 5) Return well to active status injecting water through Lancie-Mattix parts. 3550-3643'.
