Re: Application of Western Oil Fields,
Inc. for approval of a non-standard
Gas Proration Unit, Blinebry (Gas)
Pool, Lea County, New Mexico.

Gentlemen:

Western Oil Fields, Inc., respectfully makes application for approval of an 80-acre non-standard gas proration unit in the Blinebry (Gas) Pool, comprised of the N/2 of NE/4 of sec. 36, T22S, R37E, Lea County, New Mexico, with the Gulf State No 1A being the unit well, and in support thereof states the following:


1. Western Oil Fields, Inc. is owner and operator of the Gulf State Lease containing 80 acres, being the N/2 of NE/4 of sec. 36, T22S, R27-E, Lea County, New Mexico, as shown on the attached plat.
2. Western Oil Fields, Inc., is owner and operator of the Gulf State No 1 located in Unit A, 660 feet from North Line and 660 feet from East Line of sec. 36, T22S, R37E, Lea County, New Mexico.
3. This well was dually completed on October 20, 1964, as a dual completion producing from the Tubb Gas Pool and the Blinebry (Oil) Pool.
4. The Blinebry Zone in this well produces liquid hydrocarbons possessing a gravity of 44.0% API; however, the current gas-liquid ratio is in excess of the 32,000 cu. ft. per barrel limit for the Blinebry (Oil) Pool which requires gas well classification.
5. The current ratio ran during the scheduled survey was 73,062 to 1, dated May 14, 1965.
6. Western Oil Fields, Inc. proposes that the N/2 of NE/4 of sec. 36, T22S, R37E, Lea County, New Mexico, be established as an 80-acre non-standard gas proration unit in the Blinebry (Gas) Pool with the Gulf State No 1 being the unit well.
7. The proposed non-standard gas proration unit will meet the requirements of Rule 5(c) of order No R-1670, General Rules and Regulations for Southeastern New Mexico and Special Rules and Regulations, Blinebry (Gas) Pool.

- a. The proposed non-standard proration unit consists of less acreage than a standard proration unit.
 - b. The non-standard unit consists of contiguous quarter - quarter section.
 - c. The unit lies wholly within a single governmental quarter section.
 - d. The entire unit may reasonably be presumed to be productive of gas from the Blinbry (Gas) Pool.
 - e. The length or width of the unit does not exceed 2640 feet.
8. By copy of this letter all operators owning interest in the quarter section in which the proposed unit is located and all operators within 1500 feet of the unit well are notified by registered mail of the intent of Western Oil Fields, Inc. to form the proposed non-standard gas proration unit. Offset operators notified are:

Based upon the facts recited above, Western Oil Fields, Inc. requests that the New Mexico Oil Conservation Commission approve administratively the non-standard gas proration unit described above.
