Raptor Resources, Inc. respectfully requests your approval of this administrative application for the subject Unorthodox Gas Well Location and Simultaneous Dedication.

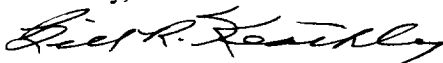
Raptor Resources, Inc. is planning to re-complete it's State "A" A/C 1 Well No. 58 in the Jalmat Tansil Yates 7-Rivers (Pro Gas Pool. It is our desire to also simultaneously dedicate the existing 480 acre Proration Unit assigned to our well nos. 16, 29, 34, 62, 67, 85, 99, and 103 to all nine wells. As a result, the location of Well No 85 becomes unorthodox in that it is less than 990 feet from the outer boundary of the proration unit. The location of Well No 85 is 1980' FNL and 1980' FEL of Section 11, T-23-S, R-36E, Lea County, New Mexico. Previously approved orders are R 9073, R4361, NSL 2723, NSL 2723A, NSL 2723B and NSL 2723C.

The offset operator plat shows that Arco Permian, Conoco Inc, Texaco and Arch Petroleum, as the offset operators that could be affected by this unorthodox location. Please find enclosed evidence that they have been notified of this application.

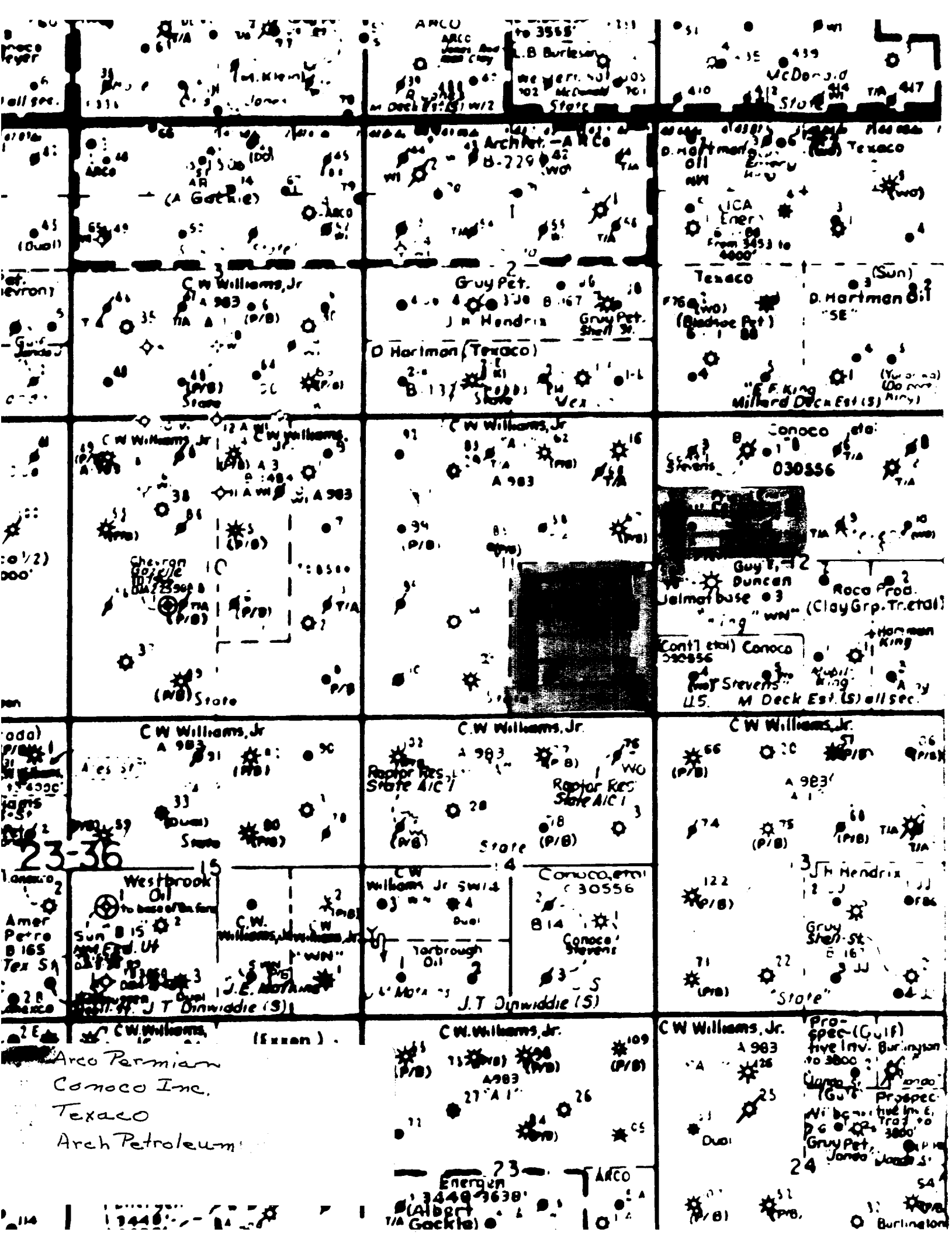

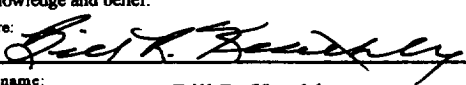
