Pressure built to 1900# and broke to 300#, increased rate to 1-1/4 BPM after break. SIP 0. On potential test 2 hrs. ending 6 A.M. 5-25-64 pump Queens 63 BPD and 40 BPM. GOR 1400/1 Grty 34%. Recompleted in Queens from perforations 3534'-3600'. After perforations same name 3534'-3539' for Calendar day allowable 37 BPD.
