
DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Acid treated perforations in 5-1/2" casing from 7145-7100' with 1000 gals 15% NE acid. Inj rate 33 gpm. TP 3000-3800#. CP packer. Acid treated perforations in 5-1/2" casing from 7076-7054' with 500 gals 15% NE acid. Inj rate 6 gpm. TP 2000-1400#. Acid treated perforations in 5-1/2" casing from 6964-6913' with 1000 gals 15% NE acid. Inj rate 42 gpm. TP 2900-2200#.

Swabbed and recovered all lead oil. Well kicked off. Flowed 170 bbls oil, 11 bbls acid water 24 hours.
